GENERAL RELEASE FOR ALL PROGRAMMING- I do hereby release, hold harmless, and discharge Judge Rachel L. Bell, Davidson County General Sessions Court, the Music City Community Court and all its staff and officers; Criminal Court Clerk, Howard Gentry and the Davidson County Criminal Court Clerk's Office; Metropolitan Government of Nashville, TN, Davidson County; the TN Department of Transportation; Metro Beautification; Metro Nashville Police Department; Metro Sheriff's Office; the Davidson County Public Defender and District Attorneys' Office; all volunteers, all vendors and Pro Bono Attorneys, their officers, agents, employees, successors and/or assigns.

PHOTO & VIDEO RELEASE- I hereby grant permission for photos or videos of my likeness and sound of my voice as recorded on audio or video to be used as by the Music City Community Court for informational, educational or promotional purposes.

ATTORNEY LIABILITY RELEASE- I do hereby release, hold harmless and discharge the Pro Bono Attorneys, Law School Students or Universities from any legal liability or assumption of forming a legal/client relationship or responsibility during the Saturday Music City Community Court Dockets. I understand the Pro Bono Attorney is serving only as a volunteer.

ADOPT-A-HIGHWAY PROGRAM RELEASE- I do hereby hold harmless and release my right to pursue damages in any form from any and all actions, claims, demands, or liability for injury to my person, damage to my property, or death, whether or not such liability is based upon allegations of negligence now existing or which may arise in the future from participating in the Saturday Community Service Work Return Docket. I acknowledge the fact that working in the area of roads can be a hazardous activity, and that I accept the risks associated with this work. This waiver shall bind the acknowledger/signer, the signer's heirs, next of kin, executors, administrators, successors and or assigns.

EXPUNGEMENT PARTICIPANT NOTICE- Please be advised that participation with any of our Saturday Dockets does not guarantee that all cases on your criminal record will be able to be expunged. In addition, participation in this clinic does not expedite the normal Expungement process but does get the process started immediately. There are some cases that may not be able to be expunged off your record based on the disposition and any other statutes (laws) that prohibit Expungement.

Please allow the Tennessee Bureau of Investigation (TBI) 3-6 months to process your record expungement request. Please be advised, Judge Rachel L. Bell, Criminal Court Clerk, Howard Gentry, and the volunteer attorneys have no control over the time period it takes to process your record expungement request. **Please keep all documents you received during the Saturday Court Docket in a safe place for future reference.**
