Please allow the **L.E.G.A.C.Y. HRDC/P - TEAM up to 72 hours to process your application.** Please be advised, Judge Rachel L. Bell, and the Pro Bono Volunteer attorneys, nor Rule 31 Mediators have no control over the time period it takes to process your non-payment of rent application with our financial assistance partners. We are aware there is a sense of urgency and we are using our best efforts to assist you during this time.

**Please be patient with the Team as we work to assist you during this time in your life.**

*It is our hope to aid in restoring a part of your life through this process and that you are able to proceed with keeping a roof over your head, gaining access to community-based resources, including utility and rental assistance, financial literacy, livable wage employment, and other sources that promote self-sustainability.*
